CATEGORIES

Boys & Girls u19, u17, u15, u13, u11 – maximum 64 players in each category. The TD reserves the right to amalgamate age groups if there are insufficient entries to make a workable draw. Players are only allowed to enter one category

Any player shall be entitled to enter providing that he/she is under the age of 11/13/15/17/19/ (according to the category entered on the closing date of the tournament. As specified by the European Squash Federation; to compete in all ESF registered events, all players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. Players from U11 may choose to play in two categories (U11+U13). Players from U13,U15, U17, U19 may only enter one category. The ESF has excluded juniors from Russia or Belarus to enter the event.

U11 categories are also recognised for ranking purposes by the ESF. All categories will be recognised for ranking purposes of the Polish Squash Association and will be classified as a A grade tournament.

SEEDING

Seeding will be done according to the ESF Guidelines. These can be found on the ESF website <u>https://www.europeansquash.com/page/32230/Guidelines</u>

MATCHES & SCORING

All matches will be played as best of five games, under the rules of the WSF. PAR scoring to 11 will be used at all tournaments on the ESF Junior Circuit (to 2 clear points). All game scores will be reported in full. There are at least three matches guaranteed for each player.

REFEREEING All players will be expected to mark and referee matches.

PRIZES There will be prize money in the U19 categories and trophies in all other categories.

All entries must be made through / endorsed by the relevant national federation. Any entry not endorsed by a player's national federation will not be accepted. All entries will be acknowledged and published on the tournament website www.hastalavista.pl.



EUROPEAN SQUASH ID (ESID)

The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported. Players can register for ESID with ESF through the ESF tournament software website: <u>https://www.europeansquash.com/page/25661/ESID</u>

Have you previously played a ESF event? Then your ESID should already exist. Please, check your ESID by clicking that link and choosing ,player' in the drop down menu <u>http://esf.tournamentsoftware.com/</u> ESID number starts with letters ,ES'.

COACHES

All team or individual player coaches designated by their nation as part of their event onsite management team (solely, or in attendance with an appointed team manager) at any Championship held under the auspices of ESF must be ESF Registered i.e. have a ESF European Squash ID as their licence to attend in a formal representative role. This is required at the time of them being registered to attend by their national federation.

DRAWS/SEEDINGS The seeding and timings for the first match will be Published for all players at the official website at least 5 days before the start of the event. Times of first matches will be indicated for their players. The seeding will be carried out using the ESF Junior Rankings valid at the closing date and in accordance with the ESF Junior Circuit Guidelines

Maximum draw size: 64 (3 day event).

Maximum draw size: 128 (4 day event).

The seeding lists and time of the first matches for specific age groups will be published at least 5 days prior to the start date, or alternatively a date and time for all participants to report to the TD will be stated.

Other relevant details about the venue:

Tournament Office Location: Hasta la Vista Sports Center; Check-in: All players should check-in at least one hour before their first match. Clothing:

Players must wear suitable squash attire including non-marking shoes



Eye Protection:

It is mandatory for approved eye protection to be worn at all times during competition play, including the knock up at this event. Players will not be allowed to compete without approved eye protection.

Recording of matches/Web Publishing/Live Streaming:

The recording of matches for coaching/performance analysis purposes is acceptable provided the player and/or their parents/coaches do not object. The Junior Open will be publishing draws, results, photos of players as well as live streaming.

Insurance:

Players enter and play in the tournament at their own risk. Neither the organisers nor the ESF will accept responsibility for any claims including for injury or accident. Suitable insurance must be organised by the player or the participating federation.

Hotel:

Accommodation, according to the entry form will be provided for all purchased a Hotel & Food or Accompanying package. Reservations can only be made by the tournament organisers.

Transport:

Transport according to the entry form will be provided for all purchased Hotel & Food or Accompanying package. Arrival/departure point must be Wroclaw Airport or Wroclaw main train station. On all playing days there will be a regular bus transfer service between the official hotels and the venue. Time schedule will be published before the tournament starts^{*}.

Anybody who pays only Entry Fee will need to organise their own transport.

*In the case of a small number of standard and accompanying packages, the organiser reserves the right to change the shuttle bus to the taxi paid by Hasta la Vista.



Payment:

Obligatory fee:

Entry fee: 60 EUR (entry fee + levy fee + 1 t-shirt) Entry fee for two categories U11+U13 : 90 EUR (entry fee + levy fee + 1 t-shirt)

Optional packages:

1. **Hotel and Food package: 290 EUR** (entry fee, 1 t-shirt, 2 nights' accommodation in twin room, 3 lunches, 2 dinners, 2 breakfasts, transportation from and to the nearest airport or train station, shuttle beween hotel and the venue)

2. Extra night:

a) in twin room 45 EUR per person per nightb) in single room 70 EUR per person per night

- 3. Single room supplement: + 25 EUR per person per night
- 4. Accompaying (for non-players): 235 EUR (2 nights' accommodation in twin room, 3 lunches, 2 dinners, 2 breakfasts, transportation from and to the nearest airport or train station, shuttle beween hotel and the venue)

5. **Roll-away bed fee: +13 EUR** per room per night (hotel does not offer triple rooms, there is a limited number of extra beds that can be booked into the twin rooms)



In case of withdrawal, fees will be reimbursed according to <u>ESF Junior Circuit Guidelines</u>, section E.

Withdrawal up to 14 days before the start date of a tournament: fees reimbursed in full (less bank charges).

Withdrawal 3-14 days before the start date of a tournament: 50% of fees reimbursed (less bank charges)

Withdrawal 2 days or less before the start date of a tournament: reimbursement at the discretion of the tournament organiser

However, expenses already incurred in connection with hotel bookings etc. will not be refunded.

Evaluation:

A link to an online survey will be sent to all participants after the tournament has taken place. Responses are anonymous and will be collated by the ESF office.

Safeguarding, health and safety:

Adults interacting with juniors in the organisation and running of ESF Junior Circuit events are in a position of trust and influence. They should always ensure that junior players are treated fairly, with respect, and given suitable support. Tournaments should be run in a safe, positive and encouraging environment. The host Organising Committee, including Tournament Director and Tournament Referee should be trained in safeguarding children



according to the host MNF national standards. The health and safety of all persons (players, officials, spectators, tournament staff) involved in or attending a tournament is of paramount importance. The Organising Committee, via the host MNF is responsible for ensuring an appropriate plan is in place for the tournament.

WSF

The Polish Junior Open 2022 is registered with WSF for World Ranking status for girls and boys u19.

GUIDELINES

This event complies with the European Squash Federation Junior Circuit Guidelines – a copy of which is available on the European Squash Federation website at www.europeansquash.com. All participating member nations should make sure that all relevant people (including coaches, managers and players) are aware of the Guidelines and their requirements

ESF Regulations & Penalties:

The tournament is part of the ESF Junior Circuit and will be run in accordance with the ESF Junior Guidelines, a copy of which is available on the ESF website <u>www.europeansquash.com</u>. MNFs should make sure that all relevant people (including coaches, managers and players) are aware of the Guidelines and their requirements.

The tournament will be run under the terms and conditions as set out in ESF Regulations: Code of Conduct - The tournament will be run under the terms and conditions as set out in EUROPEAN SQUASH FEDERATION PRIVACY POLICY as published on the ESF website <u>www.europeansquash.com</u>

A late withdrawal is a withdrawal made 2 days or less before the start date of the tournament. Ranking penalties may be applied to the records of the players who fail to turn up or who make a late withdrawal not supported by a medical certificate.

Please note:The medical certificate must clearly state the players name, date of birth and nature of the illness/injury the certificate must cover the date of the relevant tournament and must be sent to the ESF Office within 2 days after the final day of the tournament.

If a player:

a) Has entered a tournament and fails to turn up, he/she will receive zero ranking points for the tournament

b) Fails to play out all scheduled matches for any reason other than illness or injury, he/she may receive zero ranking points for the tournament

c) If zero points are awarded the points will count as one of the players 4 best results for the rolling 12 month period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically

d) Commits either of these offence for a second time within a 12 month period, he/she will be banned from the ESF Juniors Circuit for a period of 12 months
